
ISO 9001 Certification

Certification of your quality management system according to standard ISO 9001 participates in the success of your company by reinforcing customer satisfaction and motivation of the personnel.







The procedures

ISO 900¹1 certification is a voluntary approach. To apply for certification in the best conditions, it is desirable :

- that your quality management system has been operational for 6 months and has undergone an internal audit at least once,
- that a management review has been conducted.

It is intended for bodies of all types and sizes, regardless of the geographical, cultural and social conditions.

Combined certifications

Standard ISO 9001 on quality management systems can be used independently or integrated into any other management system.

ISO 9001 certification can be combined with other certifications (ISO 14001, ISO 45001, ISO 50001) and the audits can be coordinated. This combined audit saves you time and money, which is estimated at \sim 20%.

APAVE Group is able to offer you a **joint ISO 9001 and Quality Assurance audit** (an Apave Certification auditor accompanied simultaneously by an Apave expert in the field involved). This joint audit allows you to save time and makes for easy organisation/planning. The fields concerned by the joint audits are:

- **Lifts** (evaluation of compliance with the chosen Quality Assurance module of Directive 2014/33/EU),
- Pressure equipment (evaluation of compliance with the chosen Quality Assurance module of Directive 2014/68/EU),
- Machines (evaluation of compliance with the chosen Quality
 Assurance module of Directive 2006/42/EC),
- PPE Personal protective equipment (evaluation of Quality Assurance compliance of the production mode - Module D of EU Regulation 2016/425).
